Software Vendor Presentation - Avenir

Over the next few months, we will be hosting F280 verified software vendors to present on new standardized submittal forms that have been incorporated into their software.

Join us on December 10th as we welcome Avenir software to present a 30-minute introduction to the new standardized submittal form for CSA F280-12 heating and cooling load calculation results. The new standardized format is intended to make project reviews, assessments and approvals faster and easier. This new form will be available as a fillable PDF, and will also be integrated into design software that has been verified as compliant with the CSA F280-12 standard. This session will show the implementation in the LoopCAD and HeatCAD software programs.
