HRAI OBC Updater Course

The new Ontario Building Code (OBC) 2024 encompasses significant changes, as the code was harmonized with the 2020 National Building Code (NBC) 2020. If you currently hold HRAI certification for Residential Ventilation using Section 9.32 of the Ontario Building Code, you need to complete an updater training course to ensure you understand the specific regulatory changes and ensure your designs and projects remain compliant with Ontario's updated building standards. This course includes four modules that explain everything you need to know. Upon completion of Module 4, you can proceed to writing the final exam to demonstrate your understanding and mastery of the updated Ontario Building Code and retain your HRAI certification, which will be valid until December 31, 2031. A new worksheet is available on the HRAI website that reflects the requirements of OBC 2024 and you can click <u>here</u> to download it.
